Our names are Jack James and Paula Smith and we are from the firm Rodgers Reidy. On 15 November 2023, the Registrar of Indigenous Corporations appointed us as the special administrators of Yorta Yorta Nation Aboriginal Corporation (YYNAC) until 17 May 2024.

During this administration, we will keep you informed of progress through regular newsletters and information meetings.

Progress of special administration

We are now in stage 2 of the special administration, which is aiming to restore good operational order:

Operational matters

Funding

As the RAP, YYNAC provides a range of important programs and services to help meet the needs of the wider Yorta Yorta community. YYNAC receives the majority of its income from Victorian state government grants from the following state departments:

- Department of Energy, Environment and Climate Act
- Department of Premier and Cabinet

YYNAC has continued to operate on a **business as usual** basis. There has been no disruption to services and programs during the special administration.

Staffing – Recruitment of a new Chief Executive Officer (CEO)

Prior to our appointment, the corporation had an acting CEO in place and this arrangement has continued. The process to recruit a new permanent CEO has commenced. Pending the appointment of a permanent CEO, Rowan Jayasuriya will continue in the role of acting CEO.

Proposals were sought from a number of recruitment agencies who specialise in recruiting in the not-for-profit sector. Following an assessment of these proposals, Pipeline Talent has been selected to undertake the recruitment process. Pipeline Talent is 100% Indigenous owned and managed.

Formation of an Advisory Group

We received a number of nominations from corporation members and community members to be on the advisory group. After reviewing the nominations, we have selected the following people to be on the advisory group:

Mainly, the advisory group will help us to (among other things):

- review the rule book to strengthen governance at YYNAC
- · understand how best to strengthen YYNAC.

We make the following comments about the 2023 audited financial statements:

- The audit report was unqualified. It did include 2 matters of emphasis, but these were not qualifications
- The audited financial statements show YYNAC to be in a good financial position. It has:
 - made a profit of \$2,324,054
 - a working capital (current assets less current liabilities) surplus of \$9,769,638
 - a current ratio (current assets divided by current liabilities) of 2.71. This means for every \$1 of liabilities (money owed), YYNAC has \$2.71 of assets (money owned) which means it is able to pay its debts as and when they fall due.
